Boyfriend, formerly of South Bend, mom charged in beating of boy

Florida detective calls boy's injuries 'disturbing.'

A former South Bend man who has compiled a long criminal record but has not served much prison time over the years is being held in a Florida jail without bond for allegedly abusing his girlfriend's 12-year-old son.

Police say Thomas R. Betty recently beat the boy with his belt and fists severely enough to leave large bruises over all parts of his body. Prosecutors this week formally charged Betty, 54, with felony child abuse.

The boy told police that on March 9, a larger boy at school had threatened to beat him up and shoot him with a pellet gun at the bus stop. Fearing he would follow through, the 12-year-old had two friends stay at his house after school for protection, he told police.

One of the friends used the toilet without flushing it, and the other spilled a drink. When his mother, Amy Wojciechowski, arrived home later, she discovered he had had company when neither she nor Betty had been home, a violation of a house rule.

She told the boy that Betty would punish him when he arrived back in town four days later.

On March 13, when the boy came home from school, Betty took off his belt, dragged the boy into his bedroom and told him to climb onto the bed, the boy told police. He then hit him with his belt and fist for roughly 35 minutes, the boy told police.

At one point Betty left the room, saying, "I'm not through with you," and he returned 10 minutes later to resume the beating, the boy told police.

The following Monday at school, a student noticed the bruises and told a teacher, who filed a report with DCF, which called police.

The boy was treated and released at a hospital and then placed into protective custody with a foster family, said Port Orange Police Capt. Frank Surmaczewicz. Police arrested Betty on suspicion of child abuse, and Wojciechowski, 32, on suspicion of felony child neglect.

"The amount of bruising this child had, it was definitely disturbing," said Surmaczewicz, who heads the department's detective unit. "Physically he's doing better. Mentally, I definitely don't know."

Betty was ordered held without bail, and Wojchiechowski was released on \$20,000 bond. Police decided to arrest her because she was home during the alleged abuse and did not try to protect the boy

Before taking the boy to the hospital, they showed Wojciechowski his injuries. She showed no emotion and denied knowing about them, police said. She said she had been sleeping all day Friday when the beating occurred and never went to check on him all weekend.

5 OWIs, no prison

The threesome lived in South Bend before moving to Florida late last year, police said.

Betty operates a Daytona-area business that contracts for the manufacture, sale and distribution of LED lighting.

Betty in the late-1990s operated the Lydick Hideout, a bar in Warren Township, in western St. Joseph County. He has multiple drug and alcohol convictions over the years but has received little prison time.

In St. Joseph County, he was convicted of misdemeanor operating while intoxicated in 1984 and 1987, and felony OWI three more times, in 1999, 2004 and December 2008.

He has received no prison time for any of the OWI convictions. In the most recent case, Superior Judge John Marnocha sentenced him to one year in the Indiana Department of Correction, but suspended it and ordered the time served on probation. Because Betty already had moved to Florida by the time of his sentencing Dec. 18, Marnocha allowed his probation to be transferred to Florida.

Because of the child abuse arrest, Indiana law would allow St. Joseph County Prosecutor Michael Dvorak to file a petition to revoke the probation, which could lead Marnocha to make Betty serve that suspended year in prison. But because he would be free in six months with good-time behavior, the cost to transport Betty back to South Bend probably would not be worth it, Dvorak said.

In 2000, a jury convicted Betty of felony promoting professional gambling, as part of then-Prosecutor Chris Toth's crackdown on video poker machines in bars. Marnocha fined him \$2,500 and sentenced him to a year of probation, along with 100 hours of community service.

Criminal history factor in Florida

Betty has twice gone to federal prison on drug convictions but won early release both times. In 1980, he received a two-year sentence in federal court here for conspiracy to distribute cocaine.

He was released after serving nine months at the low-security Federal Correctional Institution in Sandstone, Minn., a prison official there said.

In 1993, U.S. District Judge Robert L. Miller Jr., also in the South Bend federal court, sentenced Betty to four years in prison for possession of marijuana with intent to distribute. But he was released on parole 15 months later from the federal prison in Terre Haute, said a U.S. Bureau of Prisons spokeswoman.

But in Florida, Betty has landed in a state where criminal history weighs heavily in sentencing. Judges have less discretion than in Indiana and must base sentences on a point system comprising various factors.

Because of his December OWI conviction, Betty has been convicted of a crime within the past 10 years. So if Betty were to be convicted, the judge must factor in all of Betty's prior convictions and set a minimum sentence accordingly, unless he finds it should be reduced by mitigating factors, said Chris Kelly, assistant state attorney in Volusia County, Fla.
