As a result of this sale only MRE and its AUTHORIZED dealers and distributors can sell, install and service the former Nebula LED lighting systems, now owned by MRE. Similarly, only MRE can use the proprietary intellectual property and technology developed and/or patented in its LED lighting and related products, as well as any derivative works thereof.

Anyone purchasing (either for their own use or for resale) or supplying LED lights and related products which in any way utilizes or infringes MRE's confidential and/or proprietary rights (including but not limited to copying, reverse engineering and patent infringement) is hereby put on notice and is subject to all legal remedies.

Furthermore, anyone who directly or indirectly works for Betty, Terran, or Affiliates (whether in the capacity of employee, consultant or contractor) or anyone who directly or indirectly invests in Betty, Terran or Affiliates (whether as a shareholder or partner, and whether in the form of debt or equity) and who in any way (directly or indirectly) utilizes or infringes MRE's confidential and/or proprietary rights (including but not limited to copying, reverse engineering and patent infringement) is hereby put on notice and is subject to all legal remedies.


